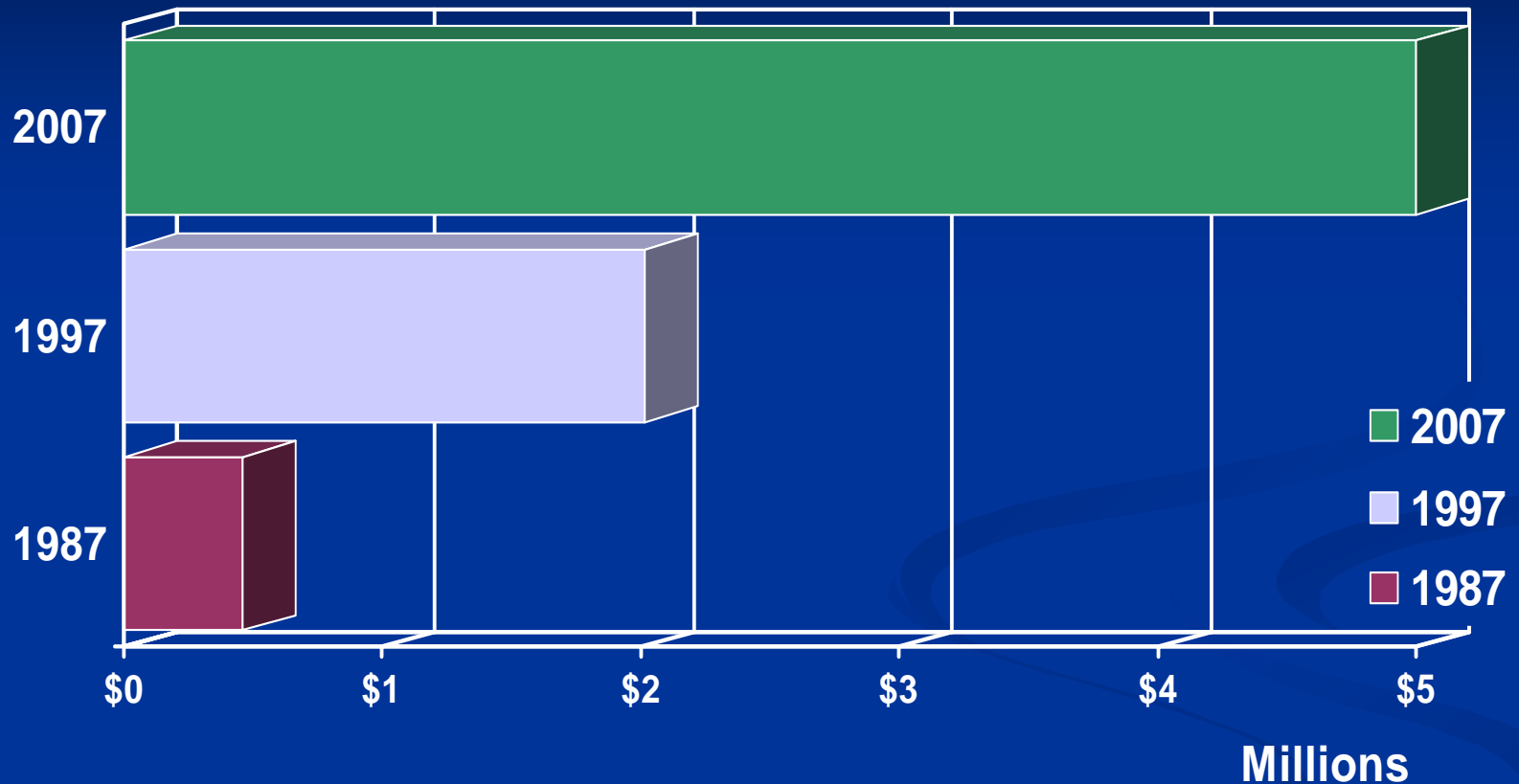

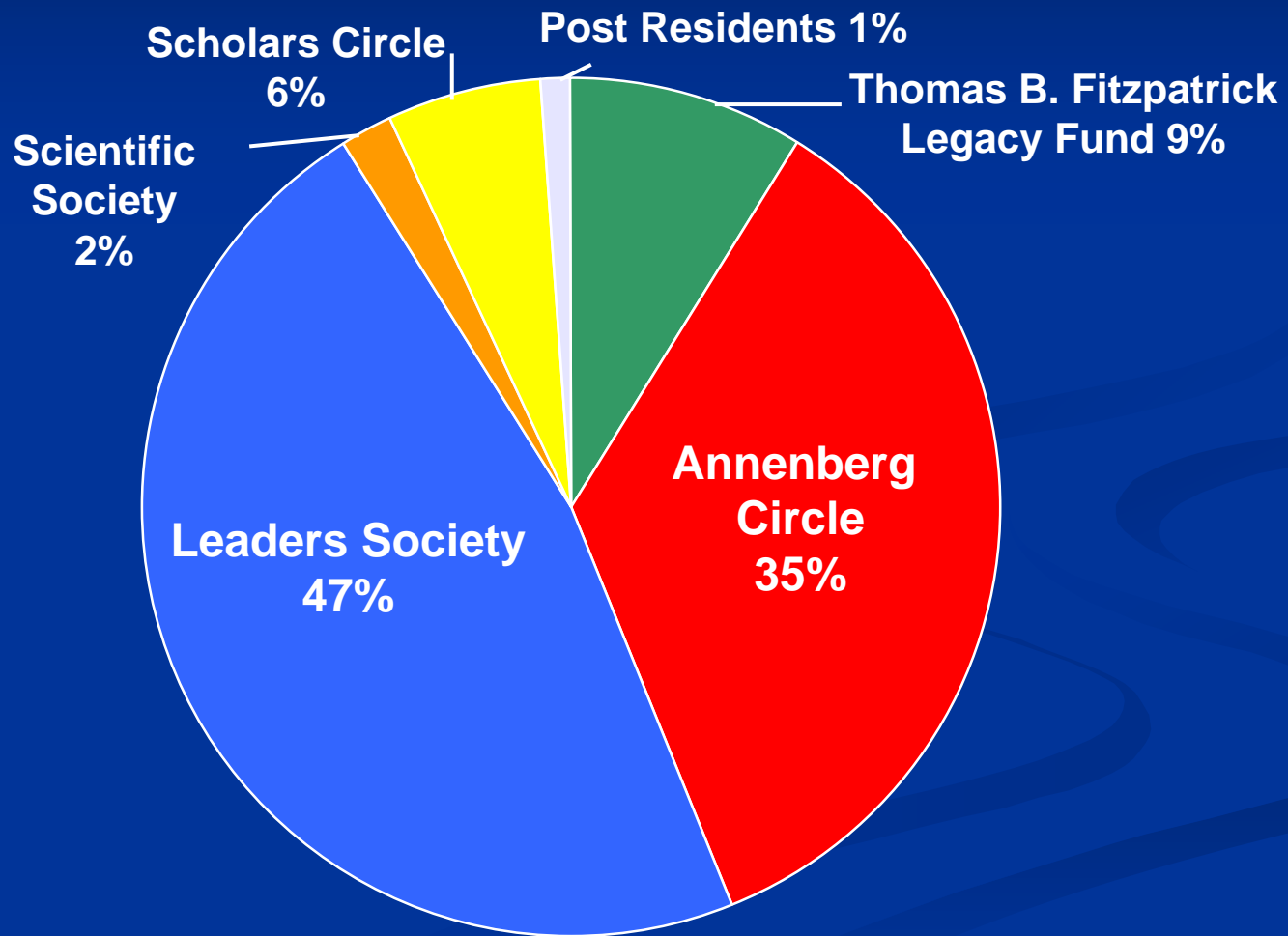
Growth in Research Funding
